## **NOTICE TO OUR NEW MEMBERS, APPOINTED BY OUR DELEGATES**

We appreciate very much your willingness to serve in the role of Members for Messiah Fund. The purpose of this Memorandum is to document formally and conveniently your duties and the considerations surrounding your duties as Members--adding details to what is already constituted in the Charter of the organization.

We anticipate that you have been selected as Members of Messiah Fund at this time because the Rapture has occurred. We also believe that you have studied the materials on the Messiah Fund's website to learn more about the Rapture and the Scriptural considerations and passages that apply. We also appreciate the fact that you have subscribed to the Testimony as set forth in Messiah Fund's Charter. We note, however, that Jesus clearly indicated that you must "endure to the end," so your commitment to the Testimony remains to be seen. We encourage you, first and foremost, to "endure to the end." We know that "the end" is the first to occur of the conclusion of your life or the Tribulation period. It is our prayer that for your sake and the sake of the Messiah Fund, you survive the Tribulation period and are able to witness the return of the Messiah.

As Members of Messiah Fund, your sole responsibility is to appoint Directors to supervise the operation of the organization. In this regard, we note that it is entirely appropriate for you to appoint yourselves as Directors and Officers in order to carry out the mission of Messiah Fund. Be sure that any other persons appointed as Directors and Officers also subscribe to the Testimony and otherwise qualify according to the terms of the Charter.

In developing Messiah Fund, we have collected and stored, digitally and physically, copies of wills, will amendments and organization charter amendments, wherein Christians and organizations have directed their assets to be given to Messiah Fund in the event of the Rapture. Accordingly, please proceed immediately to review the organization's database and files (a) to obtain a listing of all donations expected via will amendments and charter amendments as a means to locate assets that are to be given to Messiah Fund, (b) to immediately retain lawyers and law firms as necessary to initiate proceedings to recover such assets, and (c) to use and/or

liquidate the assets as necessary to promote the Gospel of the Tribulation period and to provide comfort and sustenance to saints who could subscribe to the above testimony and are subject to persecution for their faith.

We ask that you act with urgent dispatch, because we believe that the antichrist government may take action to halt the Gospel and the provision of shelter, food, protection and defense of saints. We also believe that the judgment of God on the earth will be severe and will come in waves--all as more fully detailed on Messiah Fund's website. We also believe that the Internet will become inoperable at some point during the Great Tribulation. In this regard, we believe that tangible copies of Scripture and the Gospel of the Tribulation, and tangible benefits of food, water and shelter will become of magnificent importance and should be considered as key products of the ministry. Given all of these considerations, we trust that you understand that the more you accomplish early, the more effective your ministry will be.

We also highlight here the Gospel of the Tribulation, which is apparent to us from Scripture and is the message of utmost importance for you to communicate at this time:

- Believe that Jesus Christ is the one and only Son of God and that, as God and Lord, Jesus Christ died on a cross for your sins, rose from the grave, lives forever, and will one day return as the Messiah, King of Kings and Lord of Lords.
- Reject the application of any mark (necessary for you to buy or sell) required by any government, kingdom, world leader or religion to be affixed in any form to your person, particularly on your right hand or forehead.
- Refuse to worship any person or thing other than God as described in the Bible.
- Hold fast and endure to these commitments until the first to occur of the end of your life or the end of the Tribulation period, which will be marked by the arrival of Jesus Christ as the Messiah, as described in Revelation 19:11-16.

When Jesus Christ arrives, as described in Revelation 19:11-16, you are, according to the Charter, to elect Him to serve as the principal Member, Director and Officer of the Fund. For those of you who make it to That Day, we trust that you can joyfully present Him your testimony of accomplishments in sharing the Gospel and protecting saints during the Tribulation and in reserving to Him the opportunity to direct the use of any remaining funds.

It is our sincere desire and prayer that your lives and efforts for the Messiah Fund will be blessed by the Almighty. The Messiah Fund and your work are hereby dedicated to His glory.
